SINCE ITS FOUNDING IN 1977, POST HAS SAVED MORE THAN 75,000 ACRES OF PERMANENTLY PROTECTED LAND IN SAN MATEO, SANTA CLARA AND SANTA CRUZ COUNTIES.

WE ALSO TRANSFERRED 308 ACRES TO A PUBLIC AGENCY FOR PERMANENT PROTECTION. FINALLY, WE PROTECTED 1.43 ACRES THROUGH FEE TITLE ACQUISITION. PROJECT HIGHLIGHTS ARE LISTED BELOW.

IN AUGUST 2015, POST PURCHASED AN AFFIRMATIVE AGRICULTURAL CONSERVATION EASEMENT TO PERMANENTLY PROTECT 13 ACRES FROM DEVELOPMENT AND ALSO GUARANTEES THE PROPERTY WILL REMAIN IN AGRICULTURAL PRODUCTION IN PERPETUITY. THIS PROPERTY WAS ONCE PART OF THE HISTORIC STEELE RANCH, A DAIRY OPERATION THAT COVERED THE ANO NUEVO POINT AREA IN THE 1800'S.
